

## Museum Board to Expand, Will Add 4 Members

The general business meeting held during our reunions usually is quiet and serene as routine reports are read and accepted but in June, at the meeting in Kansas City, that changed. The announcement that the Board of Directors authorized four more directors to be added at the next regular election was greeted with enthusiastic approval. Future Boards will have thirteen members...four officers and nine Directors.

#### Membership open to non·crew

It was also approved that Board membership would no longer be restricted to crew members but open to Museum members and friends. A candidate for Board membership must meet the following criteria—A) be at least twenty-one years of age; B) be a current, paid up member of the Museum Association; C) submit a 250 word essay advising why you with to serve on the Board and what experience/ability you can offer. This essay has to be mailed to Robert Ladewig, 331A Oak Hill Road, Lake Barrington, Illinois 60010-1656 no later than October 1. The adjoining article explains the new, annual election procedure.

### **Board Election Procedure**

This is the time-line procedure for electing candidates to the Board of Directors which was approved in June at the reunion in Kansas City.

Ballots will be mailed ONLY to current, paid-up members of the Museum Association!

#### OCTOBER -

During the second week of October a ballot will be mailed with a separate listing of the candidates and their profile. The ballot will be mailed only to each person who has paid their 2008 annual dues.

The ballot will be identified as such and the mailing address will be listed with the election date to be Saturday, November 15, 2008. Ballots received after that date will not be counted.

#### NOVEMBER -

Ballots will be counted and the result advised each member of the Board of Directors.

#### JANUARY -

During the third week of January 2009 a Newsletter will be mailed to the entire membership. It will include the names of the newly elected (or re-elected) members of the Board.

Our election procedure will be repeated. The 2009 membership cards will be included along with a request that 2009 dues be paid.

This poses a problem since we are chartered as a "Not-for-Profit" and as a "Charitable" organization we are not legally able to host reunions therefore we need a volunteer to accept the responsibility each year.

I think it appropriate to remind everyone that the members of the Board have never received any remuneration for their service...we are unpaid volunteers except for operation expense reimbursement.

The Directors, Officers and I appreciate the trust you have placed in us over the years, hopefully we will continue to be successful.
